THIS AGREEMENT made this 27th day of September 2018 between DSWD Field Office VII of M.J. Cuenco Ave., Cebu City, Philippines (hereinafter called "the Procuring Entity") of the one part and Deokma Eight Trading Inc. of Unit 1 Greenhills Product Compound, M.L.  - the Schedule of Requirements; (b)
 - the Technical Specifications; (c)
 - the General Conditions of Contract; (d)
 - the Special Conditions of Contract; (e)
 - and Performance Security; and (f) the Entity's Notification of Award.
 - In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
