Contract Agreement Form

THIS AGREEMENT made this 8th day of October 2018 between DSWD Field Office VII of M.J. Cuenco Ave., Cebu City, Philippines (hereinafter called "the Procuring Entity") of the one part and JCJD Construction of Block 10 Lot 31 Pueblo San Ricardo, Mohon, Talisay City, Cebu (hereinafter called "the Supplier") of the other part:

WHEREAS the Procuring Entity invited Bids for certain goods and ancillary services, viz., Repair and Improvement of Home For Girls Road Network, Drainage System, Dormitory CR, Roofing and Ceiling of Administrative Building, Gate and Laundry Area with ITB No. DSWD7-PB-2018-38 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Four Hundred Fifty-Five Thousand Six Hundred Twenty-Two Pesos (**P**1,455,622.00) (hereinafter called "the Contract Price").

 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) and Performance Security; and
 - (g) the Entity's Notification of Award.
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
