

Contract Agreement Form

THIS AGREEMENT made this 4th day of July 2017 between **DSWD Field Office VII of M.J. Cuenco Ave., Cebu City, Philippines** (hereinafter called "**the Procuring Entity**") of the one part and **Saint James Academy of Skills Technology, Inc. of Hi-ka Poblacion, Compostela Cebu** (hereinafter called "**the Service Provider**") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Re-negotiation on the Provision of Various Skills Training to SLP Beneficiaries particularly on Skills Training on Shielded Metal Arc Welding NC II with ITB No. DSWD7-NP-2017-04** and has accepted a Bid by the Service Provider for the provision of those services in the sum of **One Million Ninety Seven Thousand and Two Hundred Fifty Pesos (P1,097,250.00)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Service Provider in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




