

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT AGREEMENT**, made this 5th day of May 2022, by and between:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE VII**, a government agency duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at M.J. Cuenco Avenue Corner General Maxilom Avenue, Cebu City, Philippines, duly represented herein by its **Regional Director, REBECCA P. GEAMALA, DMPA** hereinafter referred to as “**the Procuring Entity**”.

PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at South National Highway, Brgy. Banilad, Dumaguete City, Negros Oriental, duly represented herein by its **President, Mr. JETRYLE RAY L. ALMADIN**, hereinafter referred to as “**the Service Provider**”.

WHEREAS, upon the invitation of the Procuring Entity, the Supplier submitted a bid for the **Provision of Board, Lodging and Venue for Various DSWD Activities in Dumaguete City and Nearby City/Municipalities** with **ITB No. DSWD7-PB-2022-29**, which bid was accepted by the Procuring Entity for the supply of goods and services in the amount of **One Million Four Hundred Twenty-Five Thousand One Hundred Pesos (₱1,425,100.00)** hereinafter referred to as “**Contract Price**”.

NOW THEREFORE, for and in consideration of the abovementioned premises, the Procuring Entity and the Service Provider hereby agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.
 - (a) The Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid) including corrections to the bid resulting from the Procuring Entity's bid evaluation;

- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Procuring Entity's Notification of Award

3. In consideration of the payments to be made by the Procuring Entity to the Service Provider, the Service Provider hereby covenants to provide the goods/services in conformity with the provisions of this Contract Agreement in all aspects.
4. In consideration of the provision of goods/services by the Service Provider, the Procuring Entity hereby covenants to pay the Service Provider the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the time and in the manner prescribed by this Contract Agreement.
5. Should any dispute or controversy arise from this Contract, the same shall be submitted for mutual consultation, mediation and arbitration in the order of application. The venue of the proceedings shall be in Cebu City.
6. In case of suit, the venue shall be the courts of competent jurisdiction in Cebu City, to the exclusion of all other courts.


