CONTRACT AGREEMENT

iii. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of One Million Two Hundred Twenty-Nine Thousand Six Hundred Pesos (PHP 1,229,600.00) or such other sums as may be ascertained, Panda Tea Garden Suites agrees to Rebidding for Provision of Accommodation, Food and Venue for Social Pension Program Implementation Review in Bohol for CY 2024 with Contract / ITB No. DSWD7-PB-2024-14 in accordance with his/her/its Bid.
- 4. The **Department of Social Welfare and Development Field Office VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
