CONTRACT AGREEMENT

THIS AGREEMENT, made this 27th day of December 2024 between DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT Field Office VII, of MJ. Cuenco Ave., Cor. General Maxilom, Cebu City, Philippines (hereinafter called the "Entity") and Steadfast Builders Construction Corporation of North National Road, Pitogo, Consolacion, Cebu, Philippines (hereinafter called the "Contractor").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.

 Minning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Eight Million Two Hundred Twenty-Three Thousand Two Hundred Sixty Pesos and 88/100 Only (Php8,223,260.88) or such other sums as may be ascertained, Steadfast Builders Construction Corporation agrees to Repair and Improvement of Facilities for Regional Rehabilitation Center for Youth Girls with Contract /ITB NO. DSWD7-PB-2024-64 in accordance with his/her/its Bid.
- 4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT Field Office VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
