WHEREAS, upon the invitation of the Procuring Entity, the Contractor submitted a bid for the *Rebidding of Repair and Improvement of Regional Haven for Women Storage Room, Water System, Prayer Room and other Facilities with ITB No.* DSWD7-PB-2021-50 which bid was accepted by the Procuring Entity for the supply of goods/materials, works and services in the amount of TWO MILLION THREE HUNDRED SIX THOUSAND SEVENTY-EIGHT PESOS (₱2,306,078.00) hereinafter referred to as "Contract Price".

 - (b) the Technical Specifications;
 - (c) the General Conditions of Contract;
 - (d) the Special Conditions of Contract:
 - (e) the Performance Security; and
 - (f) the Procuring Entity's Notification of Award
- 3. In consideration of the payments to be made by the Procuring Entity to the Contractor, the Contractor hereby covenants to provide the goods/materials and to execute and complete the works and remedy any defect therein in conformity with the provisions of this Contract Agreement in all aspects.
- 4. In consideration of the provision of goods/materials and execution and completion of works including remedying of defects by the Contractor, the Procuring Entity hereby covenants to pay the Contractor the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the time and in the manner prescribed by this Contract Agreement.
