- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Procuring Entity's Notification of Award
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier, the Supplier hereby covenants to provide the goods/services in conformity with the provisions of this Contract Agreement in all aspects.
- 4. In consideration of the provision of Procuring Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the time and in the Agreement.
- Should any dispute or controversy arise from this Contract, the same shall be submitted for mutual consultation, mediation and arbitration in the order of application. The venue of the proceedings shall be in Cebu City.
- 6. In case of suit, the venue shall be the courts of competent jurisdiction in Cebu City, to the exclusion of all other courts.
