TANTIANSU, hereinafter referred to as "the Supplier".

WHEREAS, upon the invitation of the Procuring Entity, the Supplier submitted a bid for the Supply and Delivery of Food and Non-Food Items for Center and Residential Care Facilities for CY 2022 (Lot 4 - Meat) with ITB No. DSWD7-PB-2022-15, which bid was accepted by the Procuring Entity for the supply of goods and services in the amount of NINE HUNDRED TWELVE THOUSAND AND THIRTY-ONE PESOS (Php 912,031.00) hereinafter referred to as "Contract Price".

- (a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid) including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract:
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Procuring Entity's Notification of Award
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier, the Supplier hereby covenants to provide the goods/services in conformity with the provisions of this Contract Agreement in all aspects.
- 4. In consideration of the provision of goods/services by the Supplier, the Procuring Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the time and in the Agreement.
- Should any dispute or controversy arise from this Contract, the same shall be submitted for mutual consultation, mediation and arbitration in the order of application. The venue of the proceedings shall be in Cebu City.
- 6. In case of suit, the venue shall be the courts of competent jurisdiction in Cebu City, to the exclusion of all other courts.
