

## Contract Agreement Form

THIS AGREEMENT made this 16th day of June 2017 between **DSWD Field Office VII of M.J. Cuenco Ave., Cebu City, Philippines** (hereinafter called "**the Procuring Entity**") of the one part and **Café-Gonzales Security Training Academy Inc. of Talisay South Central Square, Lawaan III, Talisay City Cebu** (hereinafter called "**the Service Provider**") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Provision of Various Skills Training to SLP Beneficiaries particularly on Skills Training on Security Services NC I** with **ITB No. DSWD7-PB-2017-17** and has accepted a Bid by the Service Provider for the provision of those services in the sum of **Seven Million Five Hundred Ninety Nine Thousand Six Hundred Twenty Pesos (P7,599,620.00)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Service Provider in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
