Invitation to Bid</p>	<ul style="list-style-type: none"> The equivalent amount of the percentage in Single Largest Completed Contract (SLCC) shall be specifically indicated in Section I. Invitation to Bid in order for the participating bidders to have a guide as to the equivalent amount of the contract that they should present in their bid documents. <p>It was given an emphasis <i>that bidders should have completed, within three (3) years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, at least 25% of the ABC, however, it can also an aggregate of two or more similar completed contracts, provided that there is one contract equivalent to at least half of the 25% of the ABC. ✚ *ITB Clause 15, states that “Each Bidder shall submit one (1) original and one (1) copy of the first and second components of its bid. **Copy 1 should be a replica of the original as to appearance and contents.**”*

✚ *ITB Clause 19.2, **Detailed Evaluation and Comparison of Bids** states “Partial bid is not allowed. The goods are grouped in a single lot and the lot shall not be divided into sub-lots for the purpose of bidding, evaluation, and contract award. In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.*

✚ *ITB Clause 20.1, **Post Qualification** states “Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS.**”*

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

1. All food items must in good quality; free from abnormal discoloration, foul smelling odor and molds; safe and suitable for human consumption.
2. Supplier will provide plastic or carton egg tray for every 5 pieces of eggs per child. Packed per CDC (child development center).

3. Canned goods must have no dents and rust, has label and must indicate the manufacturing and expiration dates.
4. Expiration date of grocery items must be at least 6 (six) months from delivery date.
5. All food items must be delivered on the same day. To avoid shortage, supplier must bring extra quantity of food items.
6. Defective or spoiled items must be replaced by the supplier on the same day (e.g broken egg/s, spilled oil, dented canned goods).
7. Prices are inclusive of the following:

7.a Packaging Materials:

Items must be packed according to classification using durable plastic with due consideration of the transportation especially the rice.

7.b Final Packaging:

It must be labelled per CDC (child development center) and must be placed in a clean and durable eco bag or “sako” bag to be provided by the supplier per CDC on the first delivery and to be used on the succeeding deliveries until the end of the implementation if still usable, otherwise, supplier shall replace it.

7.d. Delivery:

Participating bidder must provide specific time schedule for the delivery of the items per LGU and **must attach the said document to the Section VII Technical Specifications.**

8. The winning supplier must bring their own digital weighing scale during the delivery of goods.
9. **Mode of payment:** Monthly after submission of complete and correct sales documents (Delivery Receipt and Sales/Charge Invoice) by the Supplier.
