Invitation to Bid | It was agreed to add "Project Identification No." before the reference number in order to avoid confusion between the Project Reference Number and PhilGEPS Posting reference number, since this has caused a several confusion towards the prospective bidders. Instead of using the terms "service providers" and "services" for this project, they were changed to "suppliers" and "goods" respectively. | |
| Section III. Bid Data Sheet | ITB Clause 21.2 in this section was modified which states "Service provider must have an existing Landbank of the Philippines (LBP) Account in compliance with DBM Circular Letter No. 2013-16. Participating bidder must attach a photocopy of their bank account details (bank account name, number and branch) in the bids submitted. This shall be verified during the conduct of post-qualification". Please see attached Bank Details/Info template. | |
| Section VII. Technical Specifications | As clarified by the end-user representative, they are not requiring any specific variant for the Instant Coffee Mix (Lot 2), thus modification of the technical specification specific to this item. Additional requirements/provisions for this item are as follows: The procuring entity shall accept all brands as long as they qualify to the specifications indicated in Section VII. Furthermore, the procuring entity shall conduct quality/taste tests on the samples submitted during the post qualification activities. Twin packs are not acceptable. The procuring entity will only accept single sachets. | |

Revised Section I. Invitation to Bid

Supply and Delivery of Powdered Cereal Drink and Instant Coffee Mix

1. The Department of Social Welfare and Development, Field Office VII (DSWD-FO VII), through the authorized appropriations for Fiscal Year 2021 General Appropriations Act intends to apply the sum of Eight Million Four Hundred Thousand Pesos Only (*P8,400,000.00*) payments under the contract for the Supply and Delivery of Powdered Cereal Drink and Instant Coffee Mix, consisting of two (2) lots, broken down as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DSWD Field Office VII now invites bids from **PhilGEPS registered suppliers**. Delivery of the **goods** is required within Section VI. Schedule of Requirements. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, of at least 25% of the ABC or it can also an aggregate of two or more similar completed contracts, provided that there is one contract equivalent to at least half of the 25% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

1. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

2. Prospective Bidders may obtain further information from *Department of Social Welfare and Development Field Office VII* and inspect the Bidding Documents at the address given below during *office hours*, 8:00 AM - 5:00 PM.

3. A complete set of Bidding Documents may be acquired by interested Bidders on *June 14, 2021* from the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:*

The Procuring Entity shall allow the bidder to present its proof of payment for the fees, they may present in person or through electronic means.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

4. The DSWD Field Office VII will hold a Prebid Conference on June 22, 2021, Tuesday, 2:30 PM at DSWD Field Office VII Conference Room, Cebu City and/or through video-conferencing via Google Meet using the code: procurement7, which shall be open to prospective bidders.

7. Bid opening shall be on *July 6, 2021, Tuesday, 1:30 PM* at *DSWD Field Office VII Conference Room, Cebu City* and/or *via Google Meet using the code: procurement7*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

8. The *DSWD Field Office VII* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
