SUPPLY AND DELIVERY OF FOOD ITEMS FOR SUPPLEMENTARY FEEDING PROGRAM FOR CY 2022 IN NEGROS ORIENTAL PROVINCE – 2ND DISTRICT

Issued pursuant to Section 22.5 of the IRR of Republic Act 9184 to clarify and/or anent certain provision on the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the Prebid Conference held on **October 22**, **2021**, and shall form an integral part thereof, viz:

	♣ Delivery Schedule has been modified into:
	Delivery point will be at LSWD Office, once in every two weeks (Monday or first working day of the week) for the rest of the items while for the RICE, delivery shall be once a month, during office hours, between 8:00 AM to 4:00 PM.
	It was emphasized that the rice shall be delivered once a month on the first Monday or first working day of the month, while, for the rest of the items, it shall be delivered every two weeks which is still on Monday or first working day of the week.
Section VII. Technical Specifications	 Specifications for the brown sugar, powdered tableya, powdered filled milk, canned tuna, canned beef loaf and cooking oil were modified based on the agreements during the conduct of the Prebid Conference. Details are as follows:
	• Brown Sugar , no abnormal odor; free from molds, discoloration, insects and mites; safe and suitable for human consumption; machine sealed ; 250 grams per pack

- **Macaroni**, good quality; no abnormal odor; free from molds, discoloration, insects and mites; suitable for human consumption; has label and must indicate the manufacturing **and** expiration dates; 200 grams per pack
- **Powdered Tableya**, **sachet with** no cuts and hole; safe and suitable for human consumption; has label and must indicate the manufacturing **and** expiration dates; 15 grams per sachet
- **Powdered Filled Milk, sachet with** no cuts and hole; safe and suitable for human consumption; has label and must indicate the manufacturing **and** expiration dates; known brand and must exist in the market for at least 3 years; 33 grams per sachet
- **Canned Tuna**, flakes in oil or corned tuna; unflavored; non-spicy; no dents and rust; safe and suitable for human consumption; has label and must indicate the manufacturing **and** expiration dates; 85-100 grams per tin
- Canned Beef Loaf, non-spicy; no dents and rust; safe and suitable for human consumption; has label and must indicate the manufacturing and expiration dates; 100 grams per tin
- Cooking Oil, transparent without any sediment; safe and suitable for human consumption; has label and must indicate the manufacturing and expiration dates; 80 ml per pouch
- For the additional specifications, statement of compliance for each must be indicated. Details for the final additional specifications are as follows:
