Section VII. Technical Specifications	<ul style="list-style-type: none">It was clarified during the Prebid Conference that the dimension specified in the form is an "outside dimension".It is clarified by the end-user that the <i>certification/test results shall be inspected and evaluated during the post-qualification.</i>

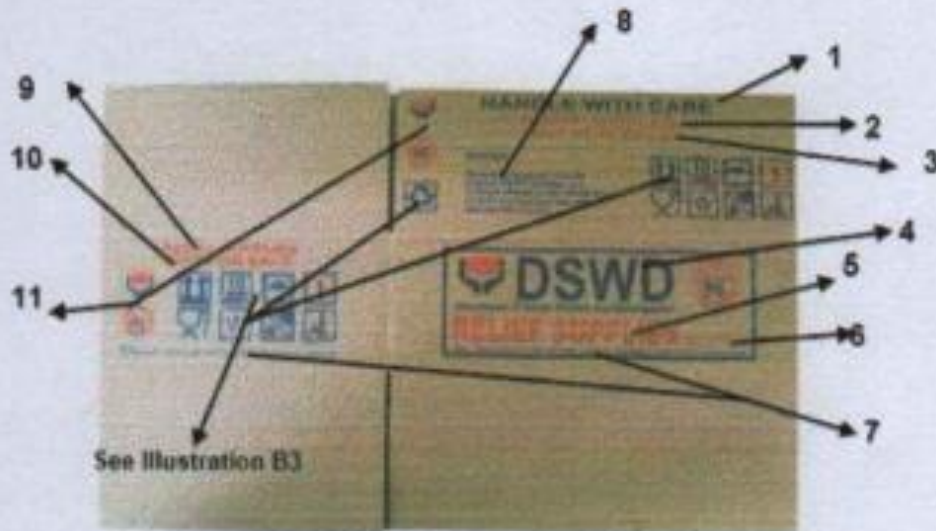

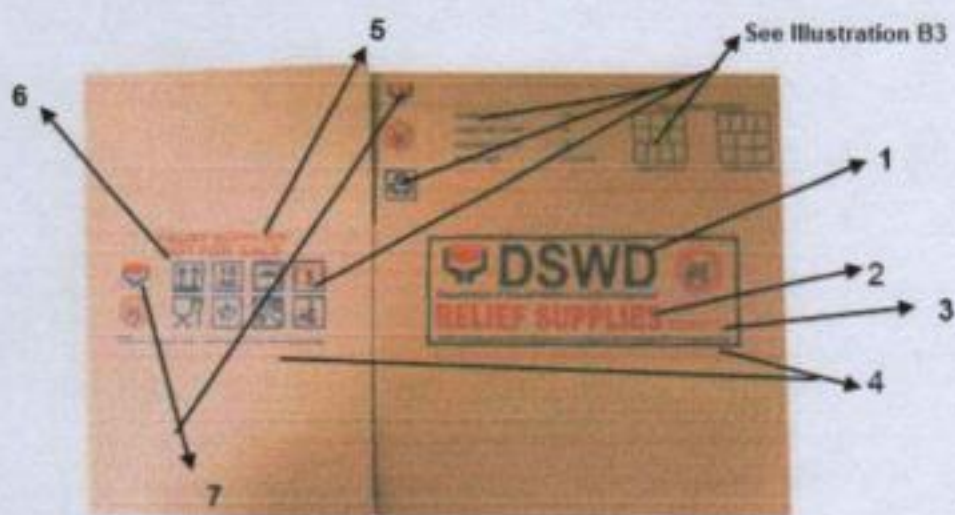
