One (1) Official Receipt or Sales Invoice or whatever documents needed to support the SLCC is acceptable (as long as it is within the required SLCC or equivalent to Php 500,000.00 for Instant Coffee Mix -Lot 1, Php 500,000.00 for Powdered Cereal Drink – Lot 2, and Php 1,000,000.00 for all lots.
