As a requirement, the Bids and Awards Committee previously required the bidder to present Latest Certificate of No Pending Cases from DOLE as of <b>December 31, 2021</b> or any later date. However, it was emphasized on the Pre-Bid Conference that such document shall be updated to the Latest Certificate of No Pending Cases from DOLE as of <b>October 31, 2022</b> or any later date.

## Section III. Bid Data Sheet

5.3	For this purpose, contracts similar to the Project shall be:
	a. The name of the Contract is <i>Provision of Janitorial Manpower</i> Services for CY 2023, similar contracts shall refer to <i>Provision of Janitorial Manpower Services</i> .
	b. completed within <i>three</i> (3) <i>years</i> prior to the deadline for the submission and receipt of bids.

12	The price of the Goods shall be quoted DDP (state place of destination) or the applicable International Commercial Terms (INCOTERMS) for this Project.
14.1	The bid security shall be in the form of a Bid Securing Declaration, or any of the following forms and amounts:
	a. The amount of not less than <i>two percent (2%) of ABC</i> or <b>equivalent to Php 96,200.00</b> , if bid security is in cash, cashier's/manager's check, bank draft / guarantee or irrevocable letter of credit; or
	b. The amount of not less than <i>five percent (5%) of ABC</i> or <b>equivalent to Php 240,500.00</b> , if bid security is in Surety Bond.
15	Each Bidder shall submit <b>ONLY</b> one (1) original copy of the first and second components of its bid.
	Detailed Evaluation and Comparison of Bids
19.2	Partial bid is not allowed. The goods are grouped in a single lot and the lot shall not be divided into sub-lots for the purpose of bidding, evaluation, and contract award.
	In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.
20.1	Post-Qualification
	Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment

	(eFPS) and other appropriate licenses and permits required by law and stated in the <b>BDS</b> .
	Participating bidders are encouraged to have an existing Landbank of the Philippines (LBP) Account in compliance to DBM Circular Letter No. 2013-16.
