Technical Specifications</b>	<p>➤ This supplemental / bid bulletin is issued to emphasize the changes on the following:</p> <ul style="list-style-type: none"> <li>• Lot 1 – Canned Tuna: Specification of the item from “nos spicy” to <b>not spicy</b>.</li> <li>• Lot 3 – Powdered Cereal Drink: Expiration date should be changed from two (2) years to <b>nine (9) months</b>.</li> <li>• Lot 4 – Instant Coffee Mix (3-in-1): Expiration date should be changed from two (2) years to <b>one (1) year</b>.</li> </ul> <p>➤ Bidders were given the instructions regarding compliance with Sec. 7 (see attached sample). In the Statement of Compliance column, there should be a statement, "COMPLY" and specification which is being complied. In the Bidder's Remarks column, the bidder shall indicate their offer.
