<b>Section VII. Technical Specifications</b>	<ul style="list-style-type: none"> <li>➤ This supplemental / bid bulletin is issued to clarify instructions on the compliance of Section VII. Technical Specifications.</li> <li>➤ In the Statement of Compliance column, the bidders should only indicate “<b>COMPLY</b>” or “<b>NOT COMPLY</b>”. There is no need to copy the item specifications.</li> <li>➤ In the Bidder’s Remarks column, under <b>Lot 1. Groceries</b>, bidders should indicate the Brand Name of the item offered whether it has been repacked (company brand) or not.</li> </ul> <p>The bidders may indicate more than one (1) brand. However, <b>ALL</b> indicated brands must be compliant to the specifications. If one (1) brand is found not compliant, it will be a ground for failure.</p>
