- 1. The Department of Social Welfare and Development, Field Office VII (DSWD-FO VII), through the authorized appropriations for Fiscal Year 2021 General Appropriations Act intends to apply the sum of Nine Hundred Nineteen Thousand Two Hundred Ten Pesos Only (\$\mathbb{P}\$919,210.00) as payment under the contract for the Negotiated Procurement of "Supply and Delivery of Food Items for Center and Residential Care Facilities for CY 2021 Meat" After Two-Failed Bidding.

 Bids received in excess of the ABC shall be automatically rejected at bid opening
- 2. The DSWD Field Office VII now invites bids PhilGEPS registered Suppliers. Delivery of the goods is required within Section VI. Schedule of Requirements. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, at least 25% of the ABC or equivalent to Php 229,802.50. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
