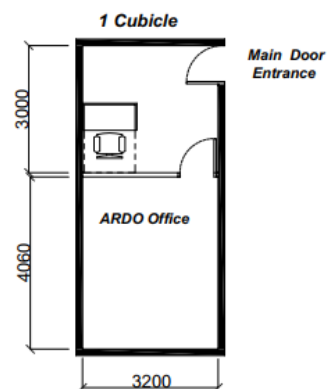

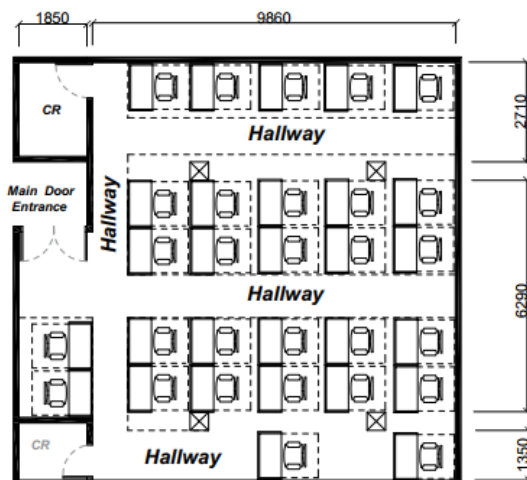

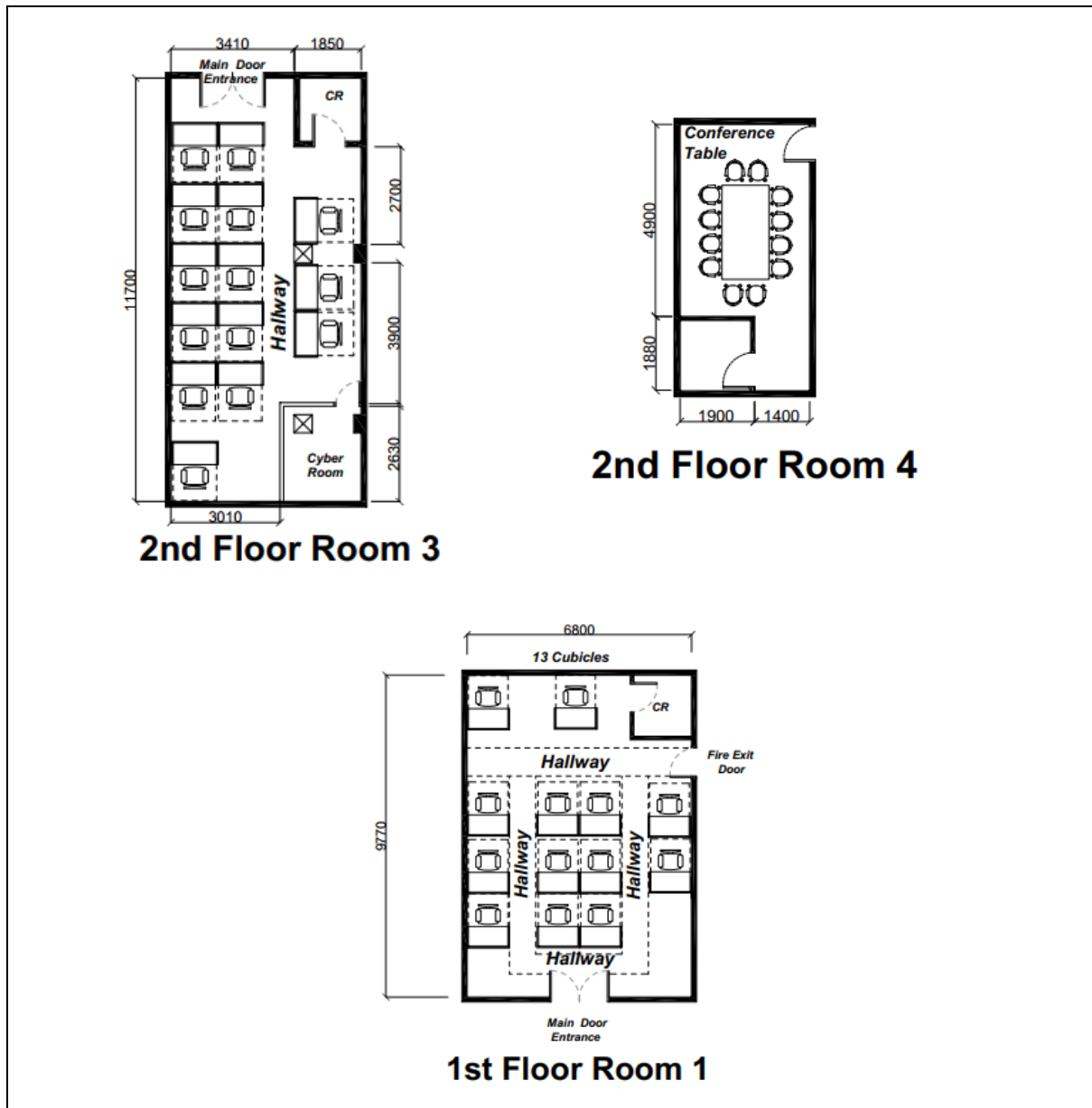


2nd Floor Room 1
